



## 2011 Cottage Site Lessee Docking Decal Information

All of us at MWCD hope that you and your family are having a great start to the New Year! Even though the days are shorter and the nights are longer and colder, boating season is just around the corner! To help you prepare for the upcoming season, we have enclosed a few items pertaining to docking decals. Please take a few moments to read the following information before requesting docking decals:

### POLICY

- The MWCD Docking Policy states in part:  
*Lessees holding a valid Cottage Site Lease may obtain docking privileges for watercraft **owned by themselves or members of their immediate family**\*. They may construct and/or install docks and other structures in compliance with MWCD Docking Specifications. A maximum of three (3) watercraft (four (4) if at least two are less than sixteen (16) feet in length and non-motorized, or eleven (11) feet or less in length if motorized) can be docked through each lease.*

\***Immediate family** includes spouse, parents, stepparents, children, and stepchildren. Your cooperation in acquiring docking privileges in compliance with the Docking Policy will help maintain conformity with the requirements of your Cottage Site.

If you have a dock location you must purchase at least one (1) docking decal each season to keep that location. During the boating season, pipes in the lake without a dock present a navigational hazard and may be impounded at the owner's expense.

### FILLING OUT THE FORM

- All watercraft docked overnight on a MWCD lake must display a docking decal. Please use the enclosed form to request docking decals and provide current information on your watercraft. Docking decal fees are located on the back of the decal request form.
- The docking decal request form includes information from the previous year's request. If this information is correct, please return the request form with payment. If any information should be changed, added or removed, please cross out and/or write in new information before returning. If a newly acquired watercraft is requested, please add the information on the form before returning.
- Please mail the docking decal application form with payment to MWCD, Attention: Tricia Miller, P O Box 349, New Philadelphia, OH 44663-0349. Docking decal forms can also be faxed, 330-364-4161, or you can bring your request form to the MWCD Main Office. As in the past, we will be unable to accept telephone docking decal requests.
