Family Vacation Cabins

Family vacation cabins at four MWCD lake parks - Atwood, Pleasant Hill, Seneca and Tappan Parks - offer beauty and economy for families, social and church groups, hunters and fishermen. Each cabin has two bedrooms and hosts up to six people comfortably.

Weekly and nightly rentals (2 night minimum) are available. Reservations are accepted at the park office and can be handled in person, by mail, by telephone and through e-mail. All reservations are subject to availability. For complete information, including current rates, contact the park office of your choice.

Organized Youth Groups

Advance reservations required. Contact the park office. Adult groups have slightly higher fees.

Pleasant Hill Lake Park Horse Camp

Camping is available at a cost of \$16.75 per night. Camping pads are sized for trailers and equipment.

Discounts

Senior Citizens receive a 10% discount from the daily rate. Senior citizens must be sixty (60) years of age to qualify. Proof of age or Golden Buckeye Card required.

Former Prisoners of War (POWs) and 100% Disabled American Veterans receive a 50% discount from the daily and 30-day rates. Verification from the Veterans Administration required.

Campsite Reservations

The MWCD accepts reservations for daily camping at the following five park locations: Atwood Lake Park, Charles Mill Lake Park, Pleasant Hill Lake Park, Seneca Lake Park and Tappan Lake Park. For details contact any of the five parks directly.

Seven-month rates are subject to lot availability. Rates are subject to change in off-season. Please contact local park office for off-season rates. Maximum lot occupancy is six (6) persons. Only one discount applies at a time. Must be 18 years of age to obtain a camping permit.
