



2021 Dock Association Docking Decal Information

All of us at MWCD hope that you and your association members are having a great start to the New Year! To help you prepare for the upcoming season we have enclosed a few items pertaining to docking decals.

RATES

Docking decal rates have not increased for the 2021 boating season.

Watercraft Type	Docking Associations
	2021 Rate
Canoe/Kayak/Paddle Boat	No Charge (Decal Still Required)
*Non-motorized 15' or less	No Charge (Decal Still Required)
PWC'S	\$120
All other watercraft	\$230
**Decals purchased after June 1st	\$25 increase per decal
Replacement/Transfer Fee	\$15

* MUST BE REGISTERED AS NON-MOTORIZED

**Please note-decal fees increase \$25 per decal beginning June 1st. This rate increase will be waived for watercraft purchased or transferred June 1st or later or for new members joining June 1st or later.

Refunds on Un-used docking decals MUST be within 30 days of purchase.

Temporary Docking Decals for Guests

The MWCD understands the practice of temporary guest docking at Associations and Clubs is not required. For 2021, Associations and Clubs that permit temporary guest docking will now have the **option** to acquire a supply of temporary decals as a point of sale convenience for their guests. POLICY

The MWCD Docking Policy states in part:

*Existing private approved (recorded in county) residential developments adjacent to MWCD property, holding a current Docking Agreement, will continue to be eligible for docking privileges if administered by a Docking Association. **Only those persons whose land within the development contains a habitable structure with an approved sewage system are eligible.** Eligible residents may obtain docking at the discretion of the Board of Directors **for watercraft owned by themselves or members of their immediate family.** (Immediate family includes spouse, parents, stepparents, siblings, children and stepchildren. Your cooperation in acquiring docking privileges in compliance with the Docking Policy will help maintain conformity with the requirements of your Docking Agreement.)*

FILLING OUT THE FORM

- Please use the Request Form to request docking decals and provide current information on watercraft owners' names and watercraft. Member's names and watercraft information have been retained from the 2020 request. In order to be consistent with our decal records, **please use only the MWCD Request Form for all decal requests.**
- **PLEASE VERIFY ACCURACY OF ALL WATERCRAFT, REGISTRATION OH #'S AND CURRENT OWNER.** OH registration number and current owner will be verified through the ODNR Watercraft registration database. Decals will not be issued for incorrect submissions.
- If a member who wants to dock a watercraft is not listed, please write in their name, along with the watercraft information, in the blank spaces below the names on the Request Form.
- As in past years, individual checks from dock association members will no longer be accepted. **One check** issued from the dock association officer requesting docking decals is required.
- Please return completed Request Form with one check made out to MWCD and send to Attn: Docking Decals, MWCD, 1319 3rd Street NW, New Philadelphia, OH 44663.
- **NOTE:** Refunds on Un-used docking decals **MUST** be within 30 days of purchase.
