SUMMARY OF MINUTES BOARD OF DIRECTORS MUSKINGUM WATERSHED CONSERVANCY DISTRICT

Held at Kent State University Tuscarawas August 18, 2023, 9:00 a.m.

A meeting of the Board of Directors of the Muskingum Watershed Conservancy District was held at Kent State University Tuscarawas, 330 University Drive NE, New Philadelphia, Ohio, on Friday, August 18, 2023, at 9:00 a.m., pursuant to notice duly given all Directors, and the general public in accordance with law.

1. ROLL CALL

Directors present were: Ronald Dziedzicki, Gordon Maupin, James Gresh, Robert Moorehead, and Jennifer Ponchak. Mr. Gresh, President of the Board of Directors, presided.

MWCD staff in attendance were Adria Bergeron, Julie Bickis, Mary Burley, Craig Butler, Jamie Carlisle, James Crandall, Shane Hart, Brad Janssen, Ryan McCleaster, Jonathan Mizer, Dylan Sayre, Boris Slogar, Eric Stechschulte, Matt Thomas, Nate Wilson, and Ethan Zucal.

2. INTRODUCTION OF VISITORS AND PUBLIC COMMENT

Also, in attendance for all or portions of this meeting were: Shelia Hurley (*Muskingum Watershed Conservancy Foundation*); Mark Waltz (*MWCD Board of Appraisers*); Allie Hinton and Zac Morris (*Rea & Associates*); Jansen Wehrley (*Guilford Township, Chippewa Subdistrict*); Reed Byrum, Debra Baughman, Bob Cooke, and Greg Clapper (*Seasonal Lot Campers at Seneca Lake Marina Point*).

Shelia Hurley of the MWCF gave a monthly report on the Foundation's activities. She reported that the MWCF Annual Golf Outing had 22 teams participate. The top four teams were: 1.) Antero/Select Energy Services; 2.) Dick Bible and Friends; 3.) AYC led by Ron Dziedzicki; 4.) Environmental Design Group. The 2024 date for the Annual Golf Outing has been set for Thursday, August 8 at Oak Shadows. Ms. Hurley also reported that the Melges 15 Sailboat was picked up in early August and already in use at Atwood Lake. The Melges 15 was purchased by the Atwood Yacht Club for their young sailors' program. She also reported the Foundation is still working on expanding board membership. Lastly, Ms. Hurley noted that the next MWCF Board meeting will be held on Wednesday, September 20 at 10am at the MWCD Annex.

Allie Hinton and Zac Morris from Rea & Associates presented to the Board the results of the 2022 District Audit. Mr. Morris stated that the audit was clean, and the only reason the audit was extended was due to the first year of the District implementing procedures required by GASB Statement No. 87. GASB Statement No. 87 required an audit of all receivables from cottage site leases. He reported that there were no instances of noncompliance for this new standard either. *Packets regarding the audit distributed by Rea & Associates are on file.*

After the presentation of the 2022 Audit of District Records by Rea & Associates, Mr. Crandall asked for the Board to vote on Item 6.02b. Please note this is cross referenced to 6.2b's corresponding section.

6.02b AUDIT OF DISTRICT RECORDS

On motion by Mr. Maupin, seconded by Mr. Dziedzicki, proposed audit report, as recommended and set forth in the above memorandum, was approved.

Mr. Thomas reported on his work with Mrs. Martin regarding her concerns about removing vegetation from a bay at Atwood where her property is located. He stated that MWCD operational policy gives the private property owner (Mrs. Martin) the ability to request the services of a contractor with MWCD oversight of the project. Mr. Thomas explained that Mrs. Martin would be able to contract with a vegetation removal specialist, but the contractor would have to work with MWCD and follow MWCD, State, and Federal guidelines.

Mr. McCleaster gave an update on his work regarding the anonymous letter received by MWCD which stated its concerns about the cleanliness of Tappan Marina, specifically seagull feces. Mr. McCleaster spoke with Atwood Marina Owner, Michael Valot, about their techniques of repelling seagulls. The Valots had placed a florescent string around the roof of the marina and this deterred seagulls. MWCD staff was in the process of installing florescent string on the Tappan Marina. Not all installation could be completed because scaffolding to reach the higher peaks of the roof was still needed.

Mr. McCleaster also stated that the anonymous letter's concern about the no mow zones was also being addressed. Signs explaining the reasoning behind the no mow zones were installed. Additionally, MWCD staff will do maintenance cutting of the no mow zones in the fall to clean out invasive species.

After addressing the anonymous letter, Mr. McCleaster addressed the concerns of the Seneca Lake Marina Point Seasonal Campers regarding the hard awning phaseout. Mr. McCleaster gave a brief history behind the decision to phase out hard awnings. He explained that in 2013 the district-wide Master Plan was being developed, the Master Plan would require some campers to be temporarily removed from their sites for construction or shoreline stabilization work. In 2015, legal counsel, Mr. Pringle, recommended the phase out of the hard awnings because of liability issues to the District. During this time, the Army Corps. of Engineers made a strong recommendation to the District that campers should not have permanent fixtures which would prevent quick and easy removal for flood mitigation purposes. MWCD staff in 2017 had decided that a phaseout of hard awnings would be designated for the year 2027. The year 2027 was chosen because 10 years is the term of the factory warranty on these products. Those campers who already had hard awnings were grandfathered in until 2027.

Mr. McCleaster stated that all parks were different, and no uniform application of campground rules could be extended regarding these hard awnings. He therefore stated that the prior campground rules about hard awnings would go back into effect until a rubric for phaseout could be developed. It was determined that the campground rules regarding hard awnings need more clarification as well. It was recommended by the Board that MWCD staff and campers create a committee to iron out some of the verbiage in the rules and determine a way forward regarding hard awnings.

Mr. Bob Cooke from Seneca Lake Marina Pointe also expressed his concerns about the need for greater safety measures around the docking systems at the lakes and parks in general. He described a few situations where campers have fell into the water and there were no safety rings or ladders on docks to help the campers out of the water. He also described an incident where a camper had a heart attack and no AED's were readily available. The Board recommended that a safety/advisory committee comprised of MWCD staff, campers, and local law and medical services be established. This committee would establish safety guidelines and enforce them at the parks.

Mr. Reed Byrum of Seneca Lake Marina Point brought up another concern. He explained that an outside vendor, not affiliated with MWCD, was being hired by campers to perform RV repair work, but that this vendor was a sex offender and on the registry. He wanted to know if MWCD could prevent him from coming onto MWCD lands. Mr. Mizer, Legal Counsel for MWCD, explained that by law, MWCD cannot ban him from public land. Mr. Mizer and Board member Mr. Dziedzicki recommended that Mr. Byrum "pull on" his legislative

levers to get Ohio law changed regarding sex offenders.

Lastly, Mr. Jansen Wehrley of Guilford Township in the Chippewa Subdistrict addressed the Board. He presented a resolution from a Guilford Township Trustee meeting (copy on file). Mr. Wehrley implored the MWCD Board not to allow the land swap between MWCD and Medina Parks to occur. The land swap of 4 acres to MWCD from MCPD is located across from Mr. Wehrley's residence. He stated that he and other Guilford Township residents didn't want the land swap to occur because they want to preserve the residential nature of the Township. The Board took the information under advisement.

3. APPROVAL OF MINUTES

On motion by Mr. Maupin, seconded by Mr. Dziedzicki, the minutes of the July 21, 2023, meeting of the Board of Directors were approved.

4. FINANCIAL

Attached (copies on file) is the financial report for the seventh-month period ending July 31, 2023. The total operating income is \$14,193,203 compared to \$16,275,292 in 2022. The Operating net income without the Utica Shale royalties is \$3,247,571, an increase of \$104,436.

The operational revenue is \$25,751,840 compared to \$27,237,374 in 2022, or a 5% decrease.

- Natural Resource and Land Management is \$2,532,549 (58% of budget), a 7% decrease from the prior year. Cottage revenue is contained in this number and is \$1,455,340 or 9% decrease from 2022. As noted previously, this is a timing issue due to a change in accounting software. Docking revenue is \$559,567 and 102% of budget.
- Oil and Gas revenue is \$10,945,632, a 17% decrease over the prior year and 26% of the budget. We continue to monitor commodity prices in relation to budgeted figures. New wells at Tappan will come online in the third quarter.
- Park Revenue is \$8,482,846 YTD (74% of budget), a 2% increase from the prior year, but slightly behind last year from budget perspective (2%).
- Marina Revenue is \$2,612,218 (72% of budget), which is up 5% over the prior year. This is a 1% increase from the prior year from budget perspective.

Operational expenses are \$11,558,637, an increase of 5% over the prior year. Personnel expenses are \$6,140,248 of this amount, and are up 11% over the prior year, which is attributable to having fewer open positions than the prior year and the addition of several new positions. Utility expenses are up 12% over the prior year. All areas are within budgeted expectations.

Capital improvement and park master plan expenses are lower, however, pay applications for the larger construction projects will increase through the reminder of the third quarter and fourth quarter.

Maintenance Assessment Fund

Maintenance Assessment revenue is \$4,124,169 through July, which is 4% greater compared with the prior year. Expenditures are \$2,916,852, a 3% decrease from the prior year. Expenditures are within budgeted expectations.

The Conservancy District is in a good financial position through the first half of the year and will continue to monitor our operational areas in relation to the budget.

7. REPORTS

7.01 UTICA ROYALTY REVENUE REPORT

Utica royalty revenue is currently generated by **112** producing wells at Clendening, Seneca, Dover, Piedmont, Atwood, and Leesville Reservoirs. A breakdown of the monthly royalty revenue can be seen on the attached page.

Utica royalties for **July** totaled **\$0.87M** (\$871,388.20) which was an approximate **13**% decrease in month-over-month revenue from June (\$1.00M).

7.02 NATURAL RESOURCES AND LAND MANAGEMENT REPORT

- Timber sales have been progressing according to plan this year. A hardwood sale was completed in late May that contained more than 238,000 board feet that was in the Piedmont region. There were multiple objectives for the sale which included thinning, regeneration, and salvage. A hardwood regeneration project located near Dellroy was also recently completed. Slowing summer pine markets delayed another section to be harvested in the same area but is anticipated it will begin in September. This harvest will focus on thinning a white pine stand that was planted in the late 70's. Finally, a sale located along the northwestern section of Clendening Lake is expected to be completed by mid-August. This sale focused on regeneration of hardwoods as well as creating early successional habitat with a final removal of white pine across an 18-acre stand.
- Invasive species control has been on-going this summer. Forestry has been diligently working on
 projects to reduce the abundance of invasive species from spreading in woodlands that are to be
 harvested/managed in the future. The primary focus of control has been on Tree of Heaven, Autumn
 olive, bush honeysuckle, and barberry. A combination of basal bark and foliar treatments are being
 utilized.
- A contractor recently completed a vine control project on a 15-acre tract in the Beach city area. The
 primary focus was to control both grapevines and oriental bittersweet in trees. These vines can be
 especially damaging to these young trees by shading out canopies and girdling young trees. The area
 will be marked for crop tree release in 2024.
- Leases and Forestry are working with Davey Tree on a potential proposal for a pilot project regarding tree assessment on MWCD lands in and around cottage areas.
- Leases is working with Engineering on the next batch of drainage and walkway improvements in the Atwood Glens cottage area.

Projects Under Construction

- Atwood Activity Center Renovation: The new walls are being framed. The middle section of the building is under roof. Electrician is pulling wires. Completion is scheduled for July 2024.
- **Atwood/Piedmont Basketball Courts:** Bids were opened on June 27th. Stanley Miller Construction was the low bidder and Notice to Proceed has been signed. Substantial completion is scheduled for August 2023.
- **Atwood Main Launch Ramp Pavement Improvements:** Project was awarded to Most Paving. Substantial completion is scheduled for October 2023.
- Clendening WWTP and Sewer Improvements: Electricians have installed communication conduits.
 Underground tanks have been installed. The contractor has been working on installing piping. The footer for the new operations building has been poured. Substantial completion is scheduled for April 2024.
- Clendening Lake Marina Cabin Area Improvements: Project will consist of a new building that will contain a
 water treatment plant in addition to an adjoining laundry facility for use by Clendening staff as well as the
 public. Substantial completion is scheduled for April 2024.
- Leesville North Fork Wastewater Treatment Plant: Project is out for bid. Bids open on August 24, 2023. This project will construct a new 8k gpd wastewater treatment facility at Leesville North Fork Marina.
- Leesville North Fork Marina Lift Station Generator: Bids were opened on July 25, 2023. CS Electric and
 Excavating was the apparent low bidder. A notice of award will be issued once funding approval is received
 from Ohio EPA.
- Pleasant Hill Park Main Lift Station Generator: The transfer switch was installed in late July, and startup is scheduled for mid-August.
- Pleasant Hill Lake Park Amenity and Activity Area: The project is substantially complete. The Contractor is working on punch list items.
- Pleasant Hill Lake Park Area A Lift Station Generator: Notice to Proceed was issued to Spring Electrical Construction Co. Substantial Completion is scheduled for September 2024.
- **Seneca Beach Amenity and Activity Areas:** Project was awarded to Wolf Creek Contracting. Project includes the addition of new sport courts, splash pad, lawn games and shade areas at the beach.
- Seneca St. Andrews and Sunset Drive Pavement Improvements: Project was awarded to Parnell and Associates.
- Tappan Marina Building Backup Generator: Wood Electric has installed new panels in the marina basement
 and is working on the generator pad and underground conduits. Generator delivery expected in January
 2024.
- **Tappan Lake Beach Concession/Restroom Upgrade:** The project is substantially complete. Waiting for drinking fountain to be installed.
- Tappan Lake Welcome Center: Contractor is installing underground utilities. Completion is scheduled for June 2024.

DREDGING AND SHORELINE (ongoing)

Dredging Program

Pleasant Hill Boat Club Dredging: Project is currently in design.

Shoreline Program

• Atwood Lake - Arcadia Drive: Project is currently in design.

• Charles Mill Lake – South Peninsula: Project is currently in design.

U.S. ARMY CORPS OF ENGINEERS PROJECTS/PROGRAMS (ongoing) Zoar Levee

• Ribbon cutting is scheduled for August 16 at 1:00 pm. Post Implementation Evaluation is underway as is the review of the levee's DSAC (Dam Safety Action Class) Rating.

Magnolia Levee

 USACE supplemental budget request is under review for the project. It is anticipated that the Project Partnership Agreement (PPA) will be sent to MWCD sometime in September with an updated final construction cost.

Senecaville Dam

Gates within the spillway structure are being cleaned and rehabilitated over the next few months. The
project will require periodic closure of the road over the dam to allow for crane operations associated with
removing the gates. Road closure and detour information are posted on MWCD's website.

7.04 CONSERVATION REPORT

Improving Water Quality

The Muskingum Watershed maintains the highest water quality compared to other similar sized watersheds in the state, but sedimentation, nutrient loading, acid mine drainage, and occasional algal blooms do impact water quality to some degree.

To have a better understanding of this dynamic system and its tributaries, MWCD hosted Dr. Laura Johnson, Director of the National Center for Water Quality Research (NCWQR) located at Heidelberg University, Tiffin Ohio, for a 3-day tour of the watershed.

One of first steps for MWCD to actively improve water quality and to become a leader in water quality research for the region is "filling the gaps" in the data where they exist.

MWCD is the largest financial supporter of the USGS gage system in the Muskingum Watershed. This network provides continuous, accurate, water quality data that is free and available online. The site selection of these 41 gage sensors and weather stations stem from the recommendations identified within the USGS Baseline Water Quality of an Area Undergoing Shale-Gas Development in the Muskingum River Watershed, Ohio 2015-16 study. Over the next few years, MWCD Conservation will be working closely with its agency partners, local colleges and universities to find better ways to collaborate, improve technology, increase monitoring, and share data.

Protecting Healthy Ecosystems

MWCD Conservation is working with a wide group of partners to better understand the populations of Little Brown Bats, *Myotis lucifugus*, currently using the Clendening Marina as a summer refuge.

Leading this investigation is Dr. Joe Johnson, University of Cincinnati. A small pilot study, supported by MWCD Conservation, has helped his lab monitor roost temperatures, track individual animal movements, and accurately estimate population size.

Bat populations have dropped dramatically across the Midwest due to White Nose Syndrome making suitable habitat capable of supporting large populations even more critical. Our Clendening bat colony is estimated to be the largest known population of Little Brown Bats in Ohio according to ODNR Division of Wildlife.

The land surrounding MWCD lakes in Carroll and Harrison Counties have been shown to provide excellent habitat to support these populations. The bats in turn remove thousands of insects every night around the lakes. The 20 bat boxes being used as part of this this multi-year study were built by Buckeye Career Center students in July 2023.

A Note on Water Quality Monitoring

This summer we have seen relatively good water quality compared to previous years. Bacteria levels have been low overall, with no *E. coli* beach advisories posted on ODH BeachGuard to date.

Results revealed this was not a harmful algal bloom (HAB) but was determined to be a species of plankton not capable of producing toxins. Information on this algae bloom was reported to the public through OEPA's Weekly HAB Update Report. The bloom has since dissipated and is no longer visible.
