Sweepstakes Official Rules

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THIS SWEEPSTAKES, ALL PARTICIPANTS AGREE TO BE BOUND BY THE FOLLOWING OFFICIAL RULES AND ALL DECISIONS OF THE SWEEPSTAKES SPONSOR, WHICH ARE FINAL IN ALL RESPECTS.

- **Sponsor:**

 - **Seneca Prize – gift basket valued up to \$500**
 - **Tappan Prize – gift basket valued up to \$500**
 - **Prizes are to be picked up at respective park offices unless special arrangements are made at time of contact.**
- **Sweepstakes Period:**
 - Participants can partake in the Sweepstakes beginning 7:00 a.m., Saturday, April 20, 2024 through 11:59 p.m. Sunday, April 28, 2024.
- **Eligibility:**
 - The Sweepstakes is open to legal residents of the fifty United States and the District of Columbia, except where prohibited, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. No purchase is necessary.
 - Employees and agents of the Muskingum Watershed Conservancy District and their immediate family members and members of the immediate family (mother, father, sons, daughters, and spouse, regardless of where they reside) and household members of each, whether or not related, are not eligible to enter the Promotion.
 - This is a U.S. promotion only, governed by Ohio law except with regard to its conflicts of law provisions. Any action under this promotion shall be venued in Tuscarawas County, Ohio.
 - This promotion is prohibited in Florida, New York, Rhode Island, and anywhere else prohibited by law.
- **How to Enter:**
 - **NO PURCHASE NECESSARY.**
 - Only one entry per person is permitted. By entering this Sweepstakes, entrants agree to be bound by these Official Rules and all decisions of the Sweepstakes Sponsor, which are final in all respects.
 - Visit Atwood, Charles Mill, Clendening, Pleasant Hill, Piedmont, Seneca, and Tappan Lake Parks and/or Marinas. Take a picture of a recreational activity. Post to social media tagging location (i.e., Atwood Lake Park, Charles Mill Lake Park, Clendening Lake Marina and Campground, Pleasant Hill Lake Park, Piedmont Lake Marina, Seneca Lake Park, Seneca Lake Marina, or Tappan Lake Park and Marina) and utilize #MWCDEarthDay2024.

- In recognition of Earth Day, participants are encouraged to pick up and dispose of any litter that may be found.
- Participants will be grouped for random selection based on location identification through social media tag.
- Winners will be chosen from a random selection of the entries gathered from individuals who have entered the Sweepstakes at each MWCD location.

- **Winner Selection:**
 - The Prize drawing will take place on Tuesday, April 30, 2024 from 1:00 p.m. through 2:00 p.m. for the prizes listed above.
 - Winners will be chosen from a random selection of the entries gathered from individuals who have entered the Sweepstakes.
 - Participants can only win one prize.
 - If no participants have entered the Sweepstakes at one location, individuals who have not won a prize at an alternative location will be entered into a random drawing despite location identification. Winner will be chosen from a random selection of the entries gathered from individuals who have entered the Sweepstakes. This process will occur until each location has identified a winner.
 - Winners will be notified by MWCD.
- **General Conditions:**
 - Invalid or ineligible entries are excluded from Sweepstakes consideration.
 - Potential winners need not be present at the drawing on April 30, 2024. In the event that a potential winner does not respond by Thursday, May 2, 2024 by 2:00 p.m., an alternative prize winner will be selected at a date selected by MWCD.
 - Failure to comply with these requirements may result in Sweepstakes disqualification and selection of an alternate winner.
 - Sponsor reserves the right to change, cancel, shorten, or extend the promotion at any time without notice.
 - Void where prohibited by law. All federal, state, and local laws and regulations apply.
 - Prizes are not transferable and second and third prizes cannot be substituted for cash value.

 - Except where prohibited by law, entry constitutes permission to use winners' names, hometowns, and likenesses for online posting, and/or any advertising and publicity without additional compensation. Muskingum Watershed Conservancy District and the employees, officers, directors, agents, and representatives of Muskingum Watershed Conservancy District are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries; (ii) telephone, electronic, hardware, or software program, network, Internet, or computer malfunctions, failures, or difficulties; (iii) errors in transmission; (iv) any condition caused by events beyond the control of Muskingum Watershed Conservancy District that may cause the contest to be disrupted or corrupted; (v) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of a prize, or from participation in the contest; or (vi) any printing or typographical errors in any materials associated with the contest. Except where prohibited, as a condition of participating in this promotion, entrant agrees that any and all disputes that cannot be resolved between the parties, and all claims and causes of action arising out of or connected with the promotion or any prize awarded, or the determination of winner shall be resolved individually, without resort to any form of class action.
