



## 2025 Private Clubs Docking Decal Information

All of us at MWCD hope that you and your club members are having a great Holiday Season! To help you prepare for the upcoming boating season, we have enclosed a few items pertaining to docking decals. Additionally, the option of utilizing a fillable PDF version of the roster will be available this year. ### POLICY

The MWCD Docking Policy states in part:

- *Private clubs maintaining a valid Club Site Lease may obtain docking privileges for watercraft owned by their members. Clubs may construct and/or install docks and other structures and may store members' watercraft on club lease premises, in compliance with MWCD Docking Specifications.*

Watercraft stored on club lease premises requires either a current seasonal or current dry dock decal. Your cooperation in administering docking privileges in compliance with the Docking Policy will help maintain conformity with the requirements of your Club Site Lease.

### RATES

Docking decal rates for the 2025 boating season.

Watercraft Type	2025 Club Docking Decal Rates
Canoe/Kayak/Paddle Boat	No Charge (Decal Still Required)
Non-motorized 15' or less <small>(MUST BE REGISTERED AS NON-MOTORIZED.)</small>	No Charge (Decal Still Required)
PWC'S	\$150
All other watercraft	\$283
Dry-Dock	\$150
Decals purchased after June 1 <sup>st</sup> <small>(fee waived for new members or watercraft)</small>	\$30 increase per decal
Replacement/Transfer Fee	\$20

Refunds on Un-used docking decals MUST be within 30 days of purchase.

### Temporary Docking Decals For Guests

Associations and Clubs that permit temporary guest docking will have the option to acquire a temporary docking decal for their guests. Please contact Andrea Striker for more details.

### FILLING OUT THE FORM

- Please use the Request Form to request docking decals and provide current information on watercraft owners' names and watercraft. Member's names and watercraft information have been retained from the 2024 request. In order to be consistent with our decal records, **please use only the MWCD Request Form for all decal requests.**
- **PLEASE VERIFY ACCURACY OF ALL WATERCRAFT, REGISTRATION OH #'S AND CURRENT OWNER.** OH registration number and current owner will be verified through the ODNR Watercraft registration database. Decals will not be issued for incorrect submissions.
- Please make note if requesting a dry dock decal.
- Blank spaces are available for new/additional members or watercraft.
